The eligible sponsor must be the primary contact for the Foundation throughout the application and funds disbursement process. The sponsorship amount upon which a gift match application is based may be constituted of funds wholly contributed from the eligible sponsor or a combination of funds collected by an eligible sponsor which are intended to benefit the gift recipient identified in the application. In the event the sponsorship amount is constituted of a combination of funds from an eligible sponsor and other donors who are not eligible sponsors, the eligible sponsor is responsible for collecting all donor funds that comprise the amount upon which the gift matching application is based. The eligible sponsor must also affirm that a minimum of 25% of the donor funds collected by the eligible sponsor are funds directly contributed by the eligible sponsor.</small>
